In our 50+ years of combined experience in real estate, we have seen many families struggle to purchase real estate and cultivate passive income.

The average sales price of a home in the United States in 2021 was \$453,700. To afford that price a family would need a minimum of 3.5% (\$15,879.50) plus an additional 2% (\$9,074.00) in closing costs which equates to a total of \$24,953.50. For many families, being able to come up with this amount of money to purchase a home is unimaginable. For this very reason, many families end up renting instead of owning their home. In most cases they are paying much more in rental costs than they would to own.

Our goal through the REIToken ecosystem is to bridge that gap and help families create generational wealth.

- This program will offer help accessing solar panels, batteries, water filtration systems, etc.
- This foundation is to be offered globally and aims to be up and running in 2023.

REAL ESTATE EDUCATION & FINANCIAL LITERACY

- REIToken will provide real estate investment strategies and resources.
- This program will provide education in the process of purchasing and selling of homes and income producing properties.
- Offer access to a network of 7,000+ real estate professionals in the U.S. and 13 other countries.

SECURITIES TOKEN FOR REAL ESTATE

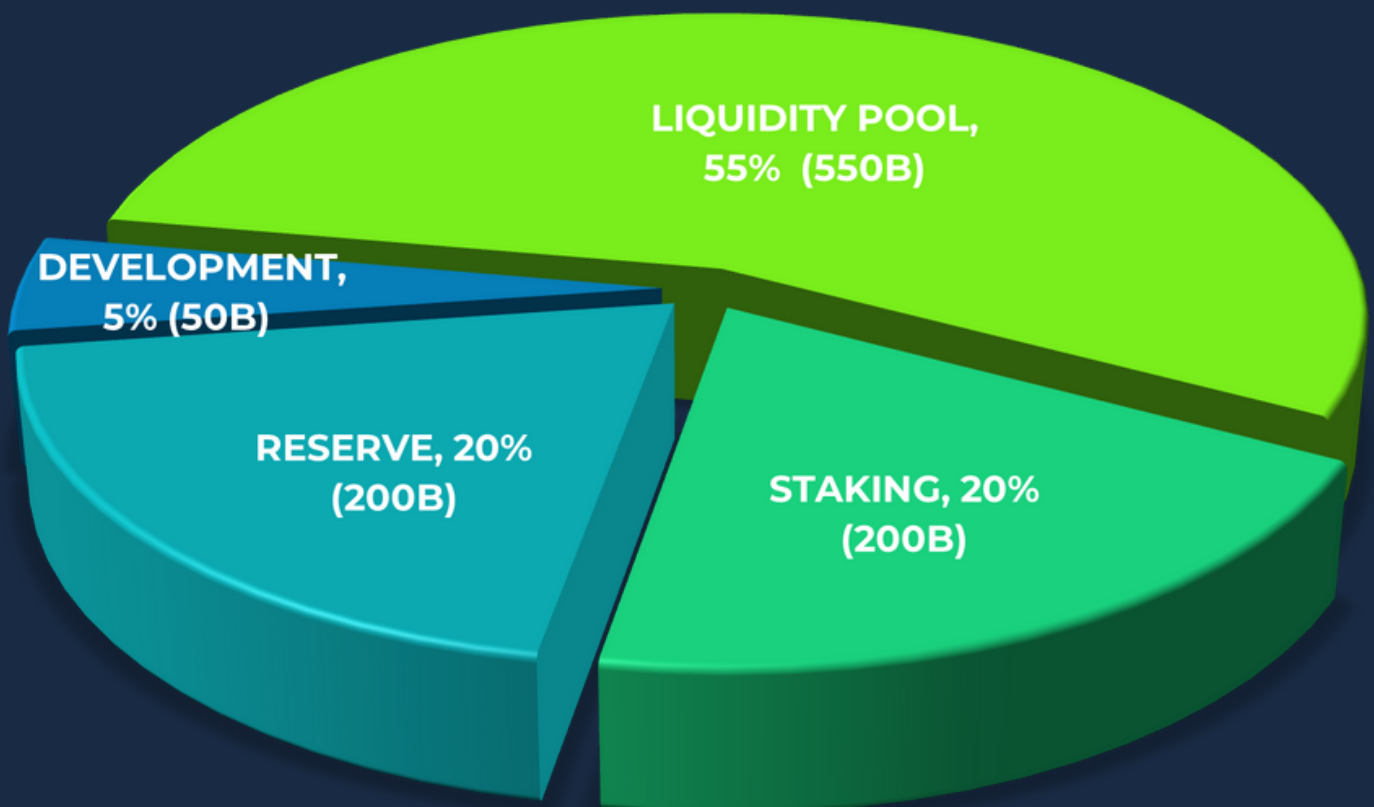
- REIToken will support the creation of a securities token for real estate.
- This securities token will be a Real Estate Investment Trust (REIT).
- This REIT will invest in residential and commercial double/triple net properties: Office buildings, Industrial, Retail, Shopping centers, Healthcare, Hospitality, and Apartment complexes.
- 90% of the revenue will be distributed to the token holders. By law and IRS regulation, REITs must pay out 90% of their taxable profits to shareholders in the form of dividends.
- REIToken will support the tokenization of individual real estate assets and future development/projects.

BUY & SELL TAX

For every purchase and sale of REIToken there will be a 10% tax. This is the breakdown of where the funds will be going:

- 3% Development in USDT
- 3% Marketing in USDT
- 2% Buy Back with Treasury Contract
- 1% Reflections in ETH
- 1% Liquidity Pool
- No Tax on Transfer

ANTI-DUMP MECHANISM

The first 72 Hours will have its own Anti-Dump Mechanism for sell tax.

The first 60 minutes of launch, the sell tax rate will be 30%. Distribution of sell tax rate as follows:

- 8% Development in USDT
- 8% Marketing in USDT
- 6% Buy Back with Treasury Contract
- 2% Reflections in ETH
- 6% Liquidity Pool

The remaining 71 hours of launch, the sell tax rate will be 20%. Distribution of sell tax rate as follows:

- 6% Development in USDT
- 6% Marketing in USDT
- 4% Buy Back with Treasury Contract
- 1% Reflections in ETH
- 3% Liquidity Pool

ANTI-WHALE MECHANISM

The first 72 Hours will have its own Anti-Dump Mechanism for sell tax.

- Max Wallet 1.0%
- Max Purchase 0.50%
- Max Sell 0.30%
